# CONCEPTUALIZING COUPLE AND FAMILY DEVELOPMENT FOR USE IN SOCIAL WORK PRACTICE

### **Challenges of Contemporary Families in China**

Rapid economic and social development in China are many families but also associated with significant stress, which has possibly led to rising family instability, divorce and re-marriage. Divorce and re-marriage rates which have increased over 200% since 1979, are expected to continue rising. (Wang & Zhou, 2010). The family dissolution rate in China's urban areas is in the 35 to 39 percent range. As the society witnesses more stressful couples and families, the need for mental health services is growing. Furthermore, due to the competitive nature of the market economy, work-life has become more fastpaced and competitive, especially in the private-owned companies in China. (Yan Yu, 2013). Family therapy, as one of the mental health services, has therefore become increasingly available. (Epstein, Curtis, Edwards, Young, & Le Zheng, 2014)

### Critical Role of Family and High Value of Family Relations


Family is a central construct in Chinese life. Although central, it is also a changing construct as China has become an increasingly international nation. (Dias, Chan, Ungvarsky, Oraker, and Cleare-Hoffman, 2011). However, the family unit still plays a critical role in the well-being of its members. Accordingly, there is a high value placed on one's ability to maintain and prioritize family relationships. (Epstein, Curtis, Edwards, Young, & Le Zheng, 2014). Family therapy, among all mental services, is comparatively more popular in China.

### Family Size and Family Structure

Rapid economic and social development in China are producing opportunities for a better standard of living for many families but also associated with significant stress, which has possibly led to rising family instability, divorce and re-marriage. Divorce and re-marriage rates which have increased over 200% since 1979, are expected to continue rising. (Wang & Zhou, 2010). The family


### **Family Development through the Life Cycle**

Each family will be developed through the life cycle: going through stages of courtship, marriage, birth of children, children in community, launching, retirement and death of one spouse.




### Family Life Processes (Richman & Cook, 2004)

According to the Family Life Processes Model delineated by Richman & Cook (2004), family life process is an on-going and changing process. Family Re-definition would commence with "Establishing a Family", "Addition of Family Members", "Family Members pursue Inter/Independence", "Separation of Family Members" and "Adults Develop Dependence".



### **Model of Social Support Process**

Social support is an exchange of resources between a provider and recipient where enacted behaviors are perceived by the recipient as enhancing their well-being. Social support would include the following: listening support, emotional support, reality confirmation support, task appreciation support, task challenge support, tangible support and personal assistance support.



### **Benefits of Social Support found in Research Studies:**

Social Support increases:

- Physical and mental well-being
- Recovery for victims of rape
- Job performance and work innovation
- Coping for at-risk families
- Academic and behavioral adjustment
- Performance on examinations & achievement tests
- School adjustment, school grades, and school attendance
- Students' ability to handle daily school hassles

### Social Support decreases:

- Stress and burnout
- Morbidity
- Feelings of loss
- Adolescent depressionDelinquent behaviors
- School drop-out rate
- School drop-out rate

In conclusion, the models on Family Development and Social Support are both pragmatic for conceptualizing modern and changing families and they may serve as a family therapy practice tool in helping stressful families.



## Training Program on Family-Oriented Social Services

November 16 - 18, 2015

CIFA, with its mission of "Converging Professional Wisdom for Family Well-Being" in the Asian Region, has made proactive responses to their training needs. In the past year, CIFA had co-organized with Hong Kong Young Women's Christian Association (HKYWCA) a 3-day training cum agency visits between November 16 and 18, 2015. This training program has served to provide an opportunity for 22 family professionals and administrators from Guangdong, Mainland China to share the successful practice experiences in Hong Kong. HKYWCA is a renowned Non-Government Organization, rendering a comprehensive range of social services to the families and communities. In particular, it has delineated innovative Family Wellness Centers, stressing family harmony and giving hope and support to all family members. In recent years, its services have a clear family orientation and a growing emphasis on intergenerational love, support and volunteering work.



The learning goals of the 3-day Training Program have comprised of: 1) Understanding of social services in Hong Kong, including family, youth and elderly services as well as continuing education & vocational training; 2) Understanding the orientation and goals of various social services; 3) Development of family-oriented social services and operational strategies; and 4) Sharing of a successful intergenerational project "Ha Chai Daddy". The training program highly encouraged professional sharing of successful practice experiences and strategies in overcoming the challenges encountered. An evaluation meeting with the leaders of the Mainland family professionals, Ms. Li ZANG (Chief Executive of 3 Social Service Centers) and Ms. Wei HE (Secretary General of Guangdong Association of Social Work Education and Practice) and their colleagues was held immediately after the training. They all found the training program and agency visits very fruitful and inspiring while the sharing with professionals and meeting with volunteers were amazing experiences. In particular, they were impressed by the innovative family wellness services and intergenerational volunteer project. Lastly, the colleagues of HKYWCA were deeply appreciated for their strong professional identity and commitment to social work, clear mission and vision, and excellent team spirit.

In the light of the increasing demand for professional training and practice sharing, CIFA is in the process of drawing up a list of resource persons/experts in Asia, encouraging active sharing of practice wisdom and contribution to regional training in future.
