Introduction

The first Asian Award for Advancing Family Well-Being ("the 3A Project") was launched in February 2010 to give recognition to outstanding initiatives that have advanced an innovative idea, model, or paradigm that can improve the quality of life for families and enhance their well-being in the Asian region. The slogan of the Project was "Aspiration for Sustainability, Innovation and Applicability" (ASIA), which attracted a total of 27 entries from 6 countries. Final round adjudication and subsequently the award presentation were taken place during the 2nd CIFA Regional Symposium in Japan on 27th November 2010. A sharing session was held in Hong Kong immediately thereafter for the finalist teams to share their knowledge, experience and good practice with different professionals sharing the same vision in advancing family well-being, either among special target groups or families in the community. Very positive and encouraging feedbacks have been received from all parties, and there is no doubt that the 3A Project 2010 was a resounding success.

To sustain the momentum of sharing and the spirit of ASIA, the second 3A Project is launched again to honor outstanding innovations to promote family health and improve the quality of family life in the region.

Objectives

The aims of the 3A Project is to provide an opportunity to encourage sharing of valuable experience which can be applied to develop family work in the Asian region to reflect the mission of CIFA in "Converging Professional Wisdom for Family Well-being". Through active participation of members and recognition given to outstanding and pioneering work, the momentum of innovation and knowledge transfer may be promoted among professionals in different countries, ultimately contributing to the sustainable development of family well-being and strengthening of family functioning in the whole of Asia.

Project Themes

Projects entering into the award competition should be able to serve one of the following purposes:

- a) Promote and enhance family functions
- b) Encourage cross-sector/professional collaboration
- c) Support families at special circumstances
- d) Confront adverse family situations and social exclusions
- e) Embrace changes for family sustainable development
- Any other areas related to family strengthening and betterment

Eligibility

- 1. Projects carried out by full members of CIFA in the Asian region or those nominated by them.
- Each applicant may only submit one project, yet projects from different units/groups of the same organization are acceptable.
- 3. On-going projects running no more than two years before deadline of the initial application but with periodic/mid-term evaluation completed are also eligible.
- Whether published or not, entries must be original.

Application and Award Procedures

- 1. Initial Application (Deadline of Submission: 24 February 2012) Application form attached to this pamphlet should be completed and submitted to the CIFA Secretariat on or before 24 February 2012, together with a project synopsis of 500 words in English for the initial screening. The synopsis should cover the following information:
-) Project name
- b) Issues/Challenges to be addressed by the project
- c) Project objectives
- d) Project beneficiaries (current and/or potential)
- e) Brief project description
- f) Brief information on project achievements
- 2. Second-round Adjudication

A maximum of 16 entries will be short-listed from the initial applications for the second-round adjudication. Successful entries will be asked to present the Project in printed format with more details, at a maximum of 5,000 words which include the text, figures, tables and appendices. In addition to the basic information already submitted at time of the initial application, the followings have also to be included:

- a) Conceptual/Theoretical framework for the project
- b) Project methodologies and implementationc) Project partnership, if any
- d) Sustainability of the project and initiative
- e) Project replicability

On top of the printed project description, audio-visual attachment of a maximum of 30 minutes may be attached.

The second-round adjudication will be conducted through tele-interviews to shortlist 8 projects to enter the final adjudication.

3. Final Adjudication

The final adjudication will be conducted during the 3rd CIFA Regional Symposium to be held in Singapore on 12th December 2012. The eight finalists from the second-round adjudication will be invited to attend the Symposium to present their projects for selection of the champion and the winners with a subsidy from CIFA.

Selection Criteria

- Project rationale and social responsiveness
- Work approach and implementation process
- Effectiveness in enhancing family functioning and its achievements
- Innovation
- Sustainability and replicability
 - Institutional synergy promoting multi-disciplinary or cross-cultural collaboration

Adjudication

To secure high standing of the award, the adjudicating panel comprises the chairperson of CIFA Council, the representative of the sponsor of this Award and respectable professionals in related fields as follows:

The result of the competition will be announced at the 3rd CIFA Regional Symposium in December 2012 when an award presentation ceremony will be held. The announcement will also be publicized thereafter at the CIFA WEP.

Awards and Prizes

There will be the Gold, Silver and Bronze Awards for the top winners. The other teams entering into the final adjudication will also be honoured with Outstanding Awards. A new award on "My Favorite Project" will be introduced, to be voted on spot by participants attending the final adjudication session at the 3rd CIFA Regional Symposium. Details of the awards and prizes are as follows:

In addition, all 8 finalists will be subsidized at US\$500 per head, up to a maximum of US\$1,000 per team to attend the 2012 CIFA Regional Symposium in Singapore to present their projects in the final adjudication.

Responsibilities of the Project Winners and the Finalists

- To sustain the momentum of the 3A Project, especially that of the award winning initiatives, data will be collected for on-going evaluation of the projects, and to track progress on the transfer of the knowledge and experience to other organizations and professionals. The gold, silver and bronze award winners are expected to participate in the process.
- Winners and finalists are expected to share their projects and experience in a sharing session that may be held immediately after the 3rd CIFA Regional Symposium in Singapore with other interested professionals.
- 3. All finalist teams will be required to provide a video upon entering into the final round and a progress report to CIFA within 6 months after the competition.

Declaration

The decision of the adjudicating panel is final and irrevocable. The organizer will not disclose the contents of the adjudicators' deliberations.

The finalist projects and evaluation reports will be uploaded onto the CIFA WEP for public sharing of the valuable ideas and experiences. A project handbook or guideline will be published for wider sharing.

CIFA reserves the right to use the submissions for non-commercial purposes in promoting the 3A Project and promoting family work.
